## Dog Costume Contest Registration Rules

### **PARTICIPANTS RULES:**

- *No age limit*
- *Must pre-register (limited to first 15 per category)*
- *Participants should arrive 30 minutes prior to the contest (a designated waiting area will be set up on the left of stage)*
- *Each participant will be given a number to wear during contest (number will be worn by participant not dog)*

***The safety of all DOGS is the RESPONSIBILITY of their owner. Each participant will enter through MAIN GATE. After contest, we encourage participants to congratulate winners and exit fair premises within 10 minutes through the MAIN GATE.***

### **CONTEST REQUIREMENTS:**

1. *All dogs must be on a leash (no retractable leashes) and be with an adult at ALL times (only **ONE** adult will be admitted in free with participant)*
2. *Dogs must be at least 6 months old*
3. *Dogs must have current shots and rabies vaccination*
4. *Dogs must wear I.D. tags at all times*
5. *No dogs in HEAT*
6. *No aggressive dogs*
7. *Costumes must be safe and comfortable for dogs.*

### **JUDGING:**

Judges will choose winners based on costume (Halloween themed), imagination, creativity and originality along with behavior & charisma. Participants are encouraged to dress up as well. Each category will have 3 judges.

Judges' decisions will be FINAL.

A first, second and third place winner will be chosen for each category
